SECRETARY'S MINUTES: Sharon made and Mary Jo seconded a motion to approve the minutes. All ayes recorded.

FISCAL OFFICER'S STATEMENTS: Monthly allocations: Gross \$36,821.18 minus Woodlink \$1,525.83 yields a Net of \$35,295.35. The Amended Official Certificate of Estimated Resources was approved by the Wood County Budget Commission. New line items added were Adult Programming and Youth Programming. Mary Jo made and David seconded a motion to approve the Fiscal Officer's report, the transfer of \$10,100 from General Other to Books Luckey \$500.00, OPERS \$500.00, Other Library Material Pemberville \$500.00, Salary Maintenance Pemberville \$500.00, Salary Maintenance Stony Ridge \$200.00, Salary Maintenance Luckey \$600.00, Maintenance OPERS \$200, Maintenance Medicare \$100.00, Maintenance Luckey \$7,500.00 and donations anonymous to Dolly Parton's Imagination Library of Ohio \$2,000.00, Luckey Friends of the Library (LALM) for Community Reads \$282.33, Third Thursday \$8.00 and General \$55.55. All ayes recorded.
