ROLL CALL: Members present were Mary Jo Bish, Ron Eckel, Steve Gross, Sharon Nigh, David St. Louis, John Selzer, and Amber Stark. Also present were Julie Getz (Fiscal Officer), Ariel Jacobs (Director), and Laura King (Secretary).

SECRETARY'S MINUTES: Amber made and Sharon seconded a motion to approve the minutes. All ayes recorded.

NEW BUSINESS

PRESENTATION OF PAINTING: Mr. Gerald C. Hill and his wife Beverly (not present) presented a painting created by Mr. Hill of the Stony Ridge Library and the business of Christian Snyder the blacksmith. Mr. Hill, who lives in Pemberville, is a commercial artist who has done work for National Geographic and other companies. He also presented a certificate of authenticity.

FISCAL OFFICER'S STATEMENTS: The monthly state allocation was not available at the time of the meeting. The library received a total of \$71,593 less than last year. Eight payments are remaining on the Luckey building loan. Sharon made and David seconded a motion to accept the Fiscal Officer's report. All ayes recorded. Steve made and Ron seconded a motion to transfer \$10,600.00 from Other-Other into the following line items: \$800.00t to Electricity (Luckey), \$9,500.00 to salaries (Luckey) and \$300.00 to Travel and Meetings Expenses (for mileage). All ayes recorded. Amber made and Steve seconded a motion to accept donations of General \$2.00 and Adult Workshop \$42.00. All ayes recorded.

DIRECTOR'S REPORT

- PEMBERVILLE FRIENDS: The Holiday Home Tour sold 187 tickets for over \$2,800 in sales.
- LUCKEY FRIENDS: Breakfast with Santa appeared to be a success at the time of the meeting.
- STONY RIDGE FRIENDS: Forty-one of the forty-five jars of Holiday Cocoa Creations were sold at \$5.00 per jar.
- POLICY COMMITTEE: The committee met in December to discuss a few policies that need updates. Once the changes have been made the board will have the opportunity to approve.
- OPLIN WEBSITE KITE: Ariel has been working on the new OPLIN site to get it ready for staff to make sure it is easy to navigate. Alisha a Caleb will be trained on it once it's approved.
- STONY RIDGE REPAIRS: Todd Henline quoted \$400 to patch the roof. Of the other two contacted only one is supposed to give a quote.
- EAGLE SCOUT FLAG DISPOSAL BOX: The project is complete and the paperwork submitted for review. When the acceptance is given Ariel will publicize the project. Ron made and David seconded a motion to approve. All ayes recorded.

STONY RIDGE EXTERIOR/INTERIOR LIGHTING: Brint Electric, Inc. quoted \$6,250, and Great Lakes Electrical Contracting quoted \$3,400. River Road Electric, LLC couldn't give a quote because they don't have a commercial building license.

BOARD OF TRUSTEES: The position was given to Steve Gross for a seven-year term.
